ORLANDO UTILITIES COMMISSION'S MOTION TO ALTER SCHEDULE FOR SITE CERTIFICATION PROCEEDINGS

The Orlando Utilities Commission ("OUC"), by and through its undersigned counsel,

respectfully requests the Administrative Law Judge ("ALJ") to alter the schedule in this

proceeding pursuant to Section 403.528(1), Florida Statutes. In support of this motion, OUC

says:

1. On June 11, 2021, OUC filed an application ("the Application") for

certification of OUC's proposed St. Cloud East-Magnolia Ranch North Transmission Line

("the Project") under the Florida Electrical Transmission Line Siting Act ("TLSA"), Sections

403.52-403.5365, Florida Statutes ("F.S.").

The Florida Department of Environmental Protection ("FDEP") and OUC 2.

provided the ALJ with a proposed schedule for the TLSA proceedings in this case. The

proposed schedule, as revised, was approved by the ALJ in an Order Establishing Schedule

(dated June 25, 2021).

The approved schedule was based on the assumption that notice of filing the 3.

Application would be published in compliance with Section 403.5363(1), Florida Statutes, and

FDEP Rule 62-17.750(1)(a)1, Florida Administrative Code ("F.A.C."), on or before July 2,

2021. Although OUC did publish notice in three (3) separate newspapers (Orlando Sentinel;

Orlando Weekly; Osceola News Gazette), the published notice did not comply with all of the

applicable requirements. Accordingly, OUC published notice again in all three (3) newspapers. The notice was published in compliance with the applicable TLSA and FDEP requirements (a) in the Orlando Sentinel and the Orlando Weekly on July 28, 2021 and (b) in the Osceola News Gazette on July 29, 2021. The approved schedule now needs to be altered, based on the actual dates when notice of filing the Application was published correctly in these newspapers.

- 4. Under the TLSA, notice of filing an application should be published within 21 days after an application is filed with the FDEP. § 403.5363(1)(b)1, F.S. The certification hearing should be conducted within 145 days after a complete application is filed with the FDEP. § 403.527(1)(a), F.S. Thus, newspaper notice should be provided to the public approximately 124 days before the certification hearing (145 21 = 124).
- 5. OUC wishes to revise the approved schedule and thus ensure that the certification hearing is held at least 124 days after the second notice of filing the Application was published in the three newspapers (July 29, 2021). OUC's proposed changes to the approved schedule are highlighted in Exhibit A, which is attached to this motion. Exhibit B (attached) contains a "clean" (final) version of the proposed schedule, which has been reorganized to show the proposed dates in chronological order.
- 6. The FDEP wishes to amend the schedule to change the filing deadline for the FDEP's Project Analysis to October 4, 2021. The FDEP had originally adjusted the schedule to allow additional time for the public to review the Project Analysis, while shortening the FDEP's time to prepare the Project Analysis. Given the other schedule changes that OUC is requesting in this motion, the FDEP would like to revise the deadline for filing its Project

Analysis, while still being consistent with the TLSA and ensuring adequate time for public review. The FDEP's proposed revision to the schedule is included in Exhibits A and B.

- 7. Section 403.528(1), Florida Statutes, provides that "[a]ny time limitation in this act [TLSA] may be altered by the administrative law judge upon stipulation between the department and the applicant unless objected to by any party within 5 days after notice or for good cause shown by any party." In this case, OUC and the FDEP each stipulate that the approved schedule should be revised in the manner shown in Exhibits A and B. Further, OUC and the FDEP each stipulate that there is good cause to revise the approved schedule, based on the facts described above. Counsel for the FDEP has authorized OUC's undersigned counsel to inform the ALJ that the FDEP stipulates to these two issues, plus the representations in paragraph 6, above.
- 8. OUC has made a good faith effort to confer with all of the parties concerning this motion, in compliance with Rule 28-106.204(3), Florida Administrative Code. On July 29, 2021, OUC sent a copy of this motion, Exhibits A and B, and an explanatory note via e-mail to each of the party representatives identified in the Certificate of Service (attached). In its e-mail, OUC asked each of the party representatives to notify OUC's undersigned counsel immediately if the party representative had any objections to this motion or the proposed schedule in Exhibits A and B. In response, the Florida Department of Environmental Protection and the Florida Department of Transportation stated that they support OUC's motion and proposed schedule. Orange County, Osceola County, the South Florida Water Management District, the St. Johns River Water Management District, and the Florida Department of Economic Opportunity each confirmed that they have no objection to OUC's motion and proposed schedule. OUC's undersigned counsel has not received any responses

from the other parties (i.e., the Public Service Commission; Department of State; Fish and Wildlife Conservation Commission). More specifically, undersigned counsel has not received any objections from any party.

WHEREFORE, the Orlando Utilities Commission respectfully requests the Administrative Law Judge to issue an order approving the proposed schedule in Exhibit B and thereby alter the deadlines for completing the remaining activities in this proceeding concerning the St. Cloud East-Magnolia Ranch North Transmission Line Project.
